

Yosemite Stanislaus Solutions Collaborative Steering Committee Meeting Summary for January 23, 2015 1:00 p.m-4:00 p.m.

FOLLOW-UP ITEMS:

- 1. Consider scheduling Mr. Joe Meyer from Yosemite Park and Ms. Shelly Crook and Ms. Carol Ewell from the Forest Service for presentations later in the year.
- 2. Co-chairs to organize nominating committee for vice-chair position.
- 3. DS Tangenberg to develop a "scorecard" on actuals vs. proposed ROD wood removal quantities and send to Ms. Lott for distribution.

SUMMARY:

I. Welcome and Introductions:

Chair Mike Albrecht welcomed the group and asked for self-introductions. He reminded members of the purpose of YSS - identifying, prioritizing and helping to find funding for forest projects. He said YSS intends to move beyond the Rim Fire burn area this year. He noted YSS has a good reputation and is being contacted by groups, even nationally, for assistance with establishing successful collaboratives.

II. YSS Process Items:

Meeting Summary from November, 2014

A member requested summaries be distributed more quickly.

Agreement: The summary was approved as emailed.

Proposed Leadership Structure and Transition

Chair Albrecht introduced the proposal. The recommendation included moving Vice-Chair Buckley into a co-chair position, appointing a vice-chair mid-year who would work closely with the current co-chairs. An additional vice-chair would be appointed towards the end of the calendar year with the intention that the vice-chairs would transition into co-chair roles beginning 2016. Co-chairs Albrecht and Buckley would continue to be involved and offer assistance a

past co-chairs. Chair Albrecht asked for two members to volunteer to serve on the nominating committee along with the co-chairs. It was noted Tuolumne River Trust, as the financial conduit, would continue to fill the finance officer role through John Amodio. Co-chair Albrecht asked that members interested in being considered for vice-chair notify YSS leadership.

Agreement: Members accepted the leadership process as proposed.

III. Follow-up Items:

Legal Update

Co-chair Buckley noted the Ninth Circuit issued a favorable opinion. The court granted the motion for filing an amicus brief by Tuolumne County and other partnering counties. This week's order does not decide the merits of the appeal and there is a hearing anticipated to be scheduled in March or April. Unless there is a court decision to curtail salvage logging, logging will continue.

General USFS Updates

District Ranger Jim Junette reported all hazard tree removal is done except for Highway 120 which should be done the end of next month. Salvage sales are anticipated to be complete by the end of summer 2015 understanding Double Fork and Ridge have not yet sold.

Mr. Steve Brink asked for a "one-pager" that lists all sales, when they sold, how much volume was produced, and what has been accomplished, with a paragraph that sums up how much of the ROD actually was completed. Deputy Supervisor Tangenberg said he would develop the scorecard. It was noted what is not accomplished through sales will have to be evaluated for stewardship contracts. This is starting next week with a pre-bid tour for biomass removal.

Reforestation Update

Mr. Marty Gmelin said the FS interdisciplinary (ID) team made a breakthrough in trying to figure out the clumping open-space planting plan to include lower slope transition to higher slope. It was noted there are whole blankets of mainly Ponderosa Pines that are dying from bark beetles and lack of water. In the burn units there are trees that survived the fire and now there is a lot of fade. It was noted some of these dying/dead trees may be removed through general salvage sales as contractors have three years to complete the work.

DS Tangenberg said the FS is going to enter scoping and NEPA processes and have workshops afterwards. If there are significant comments on the scoping, the FS will issue alternatives. Monitoring will be built into this. The FS can do tree planting up to 4,200 acres with a CE for planting for next spring. The trade-off is that acres covered in a CE cannot be treated with herbicides. It was noted there are plans to release acres that have come back through natural regeneration.

Volunteer Efforts

Ms. Clare Long highlighted a potential intern project on forestry and fire academy work with Columbia College and forest adoption projects with Groveland and Jamestown schools. Mr. Seth Connolly reported he is working with Clif Bar on tree planting on a long-term basis. He believes volunteer management is getting close to identifying about 20,000 volunteer hours for the year. They are working with the National Forest Foundation (NFF) on a draft \$25 million plan. They are also working through NFF to secure volunteer efforts through PG&E. Ms. Long will put together a list of smaller price tag needs.

A concern was raised about the source of funding and staffing for developing the new Forest Plan as it may compete with Rim Fire recovery efforts.

IV. Potential Funding Status & Project Update Report:

Natural Disaster Funding

CC Buckley described the opportunity stating the Rim Fire disaster was chosen by the governor's office for the state's application to the federal government. There is a possibility of being awarded millions of dollars. It is a national competition with a first cut phase and then full application phase. Tuolumne County is the applicant. Proposed activities for funding must fall into one of the 84 categories, but there have been strong indications that there will be an effort to fund whatever is requested if the application is one of those selected. The funds must be obligated, i.e. under contract, within a two-year period. It was stressed that this is a one-time opportunity for the FS to acquire very substantial funding.

It was requested that the SC authorize the co-chairs, Mr. Patrick Koepele, Mr. Chris Trott, and Mr. Nate Graveline to collaborate on the application on behalf of YSS. Relevant parts of the application will be brought back to YSS for action. Ms. Barbara Drake, Ms. Long, and DS Tangenberg were identified as the FS "strike team."

Agreement: There was agreement to authorize the designated YSS participants to collaborate on the application as described.

Cap & Trade

CC Albrecht reported for Mr. Trott, that in conjunction with TRT a \$1.8 million grant for biomass was submitted. If asked to submit the full application, YSS will be asked to provide a letter of support. The concept of the project has previously been endorsed by YSS. However, there will be a process for member organizations to opt out of having their organization's name listed within the letter of support.

Sierra Nevada Conservancy (SNC) & Wildlife Conservation Board (WCB) Funding CC Buckley said Ms. Mary Moore and Ms. Tracy Weddle have been putting forth an especially effective effort on coordinating and packaging the projects in a way that best addresses the focus of SNC and WCB requirements. D.R. Junette, Mr. Jim Maddox, Mr. Graveline, and Mr. Koepele are meeting regularly to help with the SNC effort. SNC is willing to take on shepherding and funding the CEQA issue. Mr. Graveline noted the big issue with WCB funding is CEQA. They are going to ask the county to be the lead agency and hope the Fish and Wildlife Preservation Fund may be the source for funding CEQA activities. He noted they are on track to put in a WCB application in May.

V. Restoration Workgroup Report:

Mr. Brink said the next task will be the 2016 interior appropriations for the FS. They will be advocating for an increase in forest products and fuels reduction funding.

VI. Project Prioritization:

CC Buckley noted YSS has worked closely on project packages to date and have been helping prioritize and enhance projects. But to move beyond that, in order to collectively review projects for YSS prioritization, YSS needs an updated FS project list that includes a subset of Rim Fire projects. YSS also needs to brainstorm whether there are priority projects that are not currently proposed by the FS such as addressing project needs in the green forest.

Agreement: DS Tangenberg will provide the project list by May 1st. The project workgroup will review the list and provide recommendations to YSS. A new project brainstorming session will be agendized.

VII. Group Education:

CC Albrecht asked that all members become familiar with the basic forest management strategies in the USFS science document GTR-220. Ms. Lott will distribute the link. He noted there is a desire to arrange a field trip to the experimental forest. CC Buckley will determine the availability of Dr. Malcolm North and Dr. Eric Knapp.

Agreement: YSS will work to potentially host two field trips to the experimental forest, one for members and one for individuals who may be influential in policy and funding activities

VIII. Other:

Mr. Brink provided an update on the six federal legislative activities he is working on. They are: appropriations, ability to do landscape scale projects, HR167, NEPA streamlining, emergency NEPA exemption, and Secure Rural Schools. He will develop a summary and send it to Ms. Lott for distribution. It was also announced GTR-247 is available online.
